



OGWA STATE LEGISLATIVE TRACKING

February 28, 2020

Below is the current status of the bills we are tracking. Thursday, February 27th, was the deadline to have bills out of committee in their respective chambers. As such, the list is now significantly shorter than it was at the beginning of the week. The list currently stands at 33 active bills and several of these are carryover bills from last session, meaning they did not advance all the way through the process last year, but are still eligible to advance in this current session.

Clicking on the bill number will launch the state legislative website where the full text of the legislation and additional information can be found. We will continue to keep you updated on the status of these as developments occur.
